IN THE MATTER OF COUNTY FINANCES IN THE HANDS OF JUDY WYATT, TREASURER OF MCMULLEN COUNTY, TEXAS.

COMMISSIONERS' COURT MCMULLEN COUNTY, TEXAS met in Regular Session, December 10, 2018.

We the undersigned County Judge and Commissioners in and for McMullen County, Texas, hereby certify that we have this date made an examination of and compared the County Treasurer's Monthly Report for the month of November, filed with us on this 10<sup>th</sup> day of December, 2018 and have found the same to be correct and in due order and that the total of all funds held by the County Treasurer is the sum of \$27,688,665.67, from which is \$7,338,514.59 in Prosperity Bank Checking Accounts of which \$2,391,534.17 is restricted use only, \$6,729,929.79 invested in Prosperity Private Investments (Raymond James), \$13,481,105.37, invested in Financial Northeastern Securities, Inc., of which \$6,402,329.82 is restricted use only, and \$139,115.92 invested in Simmons Bank (restricted for Landfill).
